## Portfolio Strategy

The Bajaj Finserv Multi Cap Fund is an open ended actively managed equity scheme aims to provide long term capital appreciation by investing 75-100% of total assets in equity and equity related securities of large cap, mid cap and small cap companies. The Scheme will maintain a minimum exposure of 25% of its total assets in each market cap category viz. large cap, mid cap and small cap. The scheme would invest in stocks across market capitalization and will remain diversified across key sectors and economic variables. The investment strategy for the Fund will focus on a contrarian approach within the equity segment, supported by our INQUBE investment philosophy. The strategy provides a structured framework to identify and invest in fundamentally strong companies that appear attractively valued.
